My wife and I bought into [REDACTED] at [REDACTED] with a view to retire there. It has a beautiful open view across the sports oval to Telopea Park and Manuka Oval. The existing oval outside our window allows us to see young adults enjoying themselves in school sports activities, and enjoy an off-lead walk with our dogs after school hours. We checked the zoning (PRZ2 – Restricted Access Recreation Zone) and were confident this outlook would never change. For a few years we lived in this apartment, and that confirmed our choice for our future.

DPA-10 changes all this. While we understand the need as explained in the supporting documents, it still affects us greatly. Will we be looking at an expanse of roofing sheets instead? Will we lose all feelings of openness with a wall maybe 20 metres away? Those on lower floors will lose that for sure. We are losing a significant home attribute, being the feeling of space, which is important in a relatively small unit. We are losing this when we thought zoning would guarantee that it will continue. It also significantly impacts the valuation of our property thus reducing our options to find something better.

We know this representation will not stop this development. We simply ask that the very significant impact to those on the [REDACTED] side of [REDACTED] be considered in the development. We have, despite checking zoning, lost out significantly and in a quality-of-life altering way.

I am a Canberra resident and a parent of a student at Telopea Park School. I am writing in support of the proposed rezoning of Montgomery Oval to facilitate the modernisation and expansion of the school's high school facilities.

Telopea Park School serves one of Canberra's most diverse and established communities, yet its facilities have not kept pace with the needs of a contemporary secondary school. The proposed gymnasium and multipurpose space would provide students with access to the kind of infrastructure that is standard elsewhere in the ACT school system. The absence of adequate indoor sports and performance facilities is a genuine disadvantage for students at the school.

The inner south presents few, if any, viable alternative sites for this expansion. The school's location within an established residential area means that the adjacent oval represents a rare and logical opportunity for consolidation of educational infrastructure in place, rather than dispersal across the suburb.

I recognise that some nearby residents have raised concerns. Those concerns deserve consideration, but they should be weighed against the broader public interest in maintaining high-quality, well-resourced public education in the inner south. The number of families whose children stand to benefit significantly outweighs the impact on a small number of adjacent properties.

I urge the authority to support the rezoning and allow this project to proceed.
