As a member of staff and also a parent at Brindabella Christian College, it alarms me to think that the car park will no longer be accessible to staff and parents. Removing this car park will cause significant danger and risk not only to staff but also students and parents, especially during drop off and pick up times. As you may be aware, it is virtually impossible to find street parking anywhere near a school during these peak times, so removing this car park will create massive traffic congestion to the neighbouring streets and surrounds. This will directly impact on local residents and potentially harm grassy areas on curbs and sidewalks.

The use of the car park does not have to be limited to private use - it can be open to the public on weekends. The existing oval is large enough as it is for two schools to use comfortably, and having a large car park near the oval would encourage public access on weekends.

It would be disappointing if the approval for continued use of the car park was rejected despite these strong arguments. I trust the right decision will be made by the ACT Government.
